# Key takeaways from the masterclass

In Finland, arts and wellbeing entrepreneurs must navigate specific licensing and regulatory frameworks to operate legally and effectively.

For example:

#### **Business Registration and Legal Structures**

- Choosing the suitable Legal Form such as a sole proprietorship, limited liability company (LLC), or cooperative. Each structure has distinct implications for taxation, liability, and administrative responsibilities.
- Registration of business with the Finnish Patent and Registration Office (PRH). The process includes selecting a unique business name and obtaining necessary identification numbers.

## **Professional Licenses and Permits**

 For the art sector, generally, creating and selling art does not require specific licenses. However, if the activities involve public performances or exhibitions, it is needed to secure appropriate permits from local authorities.













 For wellbeing services professions, such as physiotherapy, massage therapy, or other health-related services often require specific qualifications and licenses.

# **Intellectual Property Rights**

 Protection of art for artists: Instructions and information on how to safeguard artistic works, brand names, and other intellectual properties by registering them with the appropriate authorities.

# **Other Legal Considerations**

- Permits: Arts and wellbeing businesses in Finland generally do not require special permits, except for regulated professions (e.g., healthcare services).
- **Data Protection (GDPR):** Businesses handling personal data must comply with Finnish and EU privacy laws.
